

Christmas colouring-in competition Terms and Conditions

Entering the 2015 Christmas colouring-in competition (organised by Jennifer Jones – Personal Travel Manager and area representative for TravelManagers Australia in Wahroonga) deems acceptance of the following Terms and Conditions:

STANDARD TERMS

1. INTRODUCTION

- 1.1 These Terms and Conditions govern your entry into the 2015 Christmas colouring-in competition.
- 1.2 It is a requirement of submitting an application for the 2015 Christmas colouring-in competition that you read carefully, and agree to, these Terms and Conditions.
- 1.3 By submitting an application you are acknowledging that you have read, understood and accept, and that you will be bound by all of these Terms and Conditions.
- 1.4 When we accept your application, we are accepting it in New South Wales, Australia. These Terms and Conditions are governed by the laws of New South Wales.

2. THE PROMOTER

3. WHO CAN ENTER

4.6 Incomplete entries will be deemed invalid.
